Youth Rebellions in European Metropolis - Second and third generation migrant children and adolescents in search of their place in society: challenges to national and EU policies under the new Lisbon Treaty.

25-26 November 2010

The youth rebellions of the past few years in certain European Metropolis, particularly in France, showed the urgency of the integration and inclusion issue for second and third generation migrant children and youth in the societies of wealthy EU countries. This has highlighted the importance of approaching the integration issue not only in terms of fighting poverty, but also through consideration of the complexity of the culture and identity-related aspects of social inclusion: these young people were asking for respect before asking for better living conditions.

This conference aims at investigating the long-term social impacts of migration and the situation of ethnic minorities, analysing the risk factors for second and third generation migrant children and young people experiencing poverty and social exclusion; even if their families have reached a relatively affluent economic status, they still face prejudice, discrimination and violence. Whenever they lack identification and belonging, they are more vulnerable to violence and exploitation and may become more easily involved in crime. The danger of ending up in the street may be more closely linked to complex aspects of a personal identity crises within society, than to conditions of poverty in a material sense.

On the occasion of the European Year 2010 to Combat Poverty and Social Exclusion, The European Forum on Street Children will focus on raising awareness of the relatively under-investigated issue of these children's social exclusion. Tackling this issue requires actions which are targeted at the beneficiaries and their complex needs in terms of culture, taking a holistic and long-term perspective. Based on the experiences of selected experts and EFSC member organisations, the existing problems and available solutions will be analysed in order to identify innovative concepts and answers to the inclusion needs of these children while safeguarding identity and cultural needs at every stage of integration. At a policy level, the conference will aim at contributing to the discussion on the post-2010 Lisbon Agenda, by reminding policy-makers that the assumption that growth and jobs will "trickle down" to contribute to better social cohesion should not be considered as sufficient for realising a "Social Europe". The social impact of migration will be analysed in view of contributing to mainstreaming it in the 2010-2012 NSR SPSI round, and trying to contribute to the available knowledge on these relatively less investigated aspects. The role of the Open Method of Co-ordination in ensuring that specific culturally-sensitive measures are addressed to specific social problems while approaching the person in a holistic fashion will be analysed, and a joint declaration on the need for a more "social" Lisbon Agenda will be produced as a result of the conference. The approval of such a declaration will be proposed
